WHO CAN APPLY TO A POSTDOCTORAL FELLOWSHIP?

- Candidates in the field of Civil Law, Intellectual Property Protection or IT Law (comparative or cross-border research in these fields is also appreciated)
- Promising researcher of any nationality
- In possession of doctoral degree
 - » at the call deadline
 - up to 8 years from the date of PhD award
- Mobility rule: not resided/studied/work in Czechia for more than 12 months in the in the 36 months immediately prior to the deadline
- Have not submitted a MSCA-PF proposal in the previous call reaching score <70%


